FS100-10 Operating Instructions




Description

The FS100-10 is a high performance multiplying synthesizer. The 10 MHz input signal is multiplied by ten to generate a 100 MHz output signal. This output signal can be bandpass filtered and amplified if specified. The FS100-10 is provided as a board level module and the following precautions should be observed to obtain optimum performance. The DC voltage to operate the device should be +12 VDC. The positive DC should be applied to the third pin of the card edge connector located on the back of the multiplier; the VDC GND should be connected to the first pin. **The input signal level must be greater than +11 dBm**, please contact SDI if the signal level is lower than 11 dBm, otherwise the synthesizer will not function properly and noise performance will be seriously degraded. The multiplying synthesizer is not a linear device therefore the output power does not vary linearly with input power. The absolute maximum specifications should be observed to obtain the optimum performance and ensure reliability.
